



CIVHC.org Terms of Use

Effective Date: September 1, 2017

The Center for Improving Value in Health Care (CIVHC) develops, operates and maintains the website (www.civhc.org, also the "Site") in its role as a non-profit organizations and the state-designated Colorado All Payer Claims Database (CO APCD) Administrator, under Colorado law. By using the Site and the data contained therein, you agree to abide by the following Terms of Use ("Agreement"). You further agree to be bound by the terms and conditions of our Privacy Policy which together with this Agreement governs our relationship with you regarding this website.

GENERAL USE RESTRICTIONS

All information, documents, products, software and services provided on the Site, including trademarks, logos, graphics and images (the "Information") are provided to you by CIVHC or its licensors. CIVHC and its licensors shall own all right, title and interest to the Information contained on the Site.
